

ORDINANCE NO. 1013

**AN ORDINANCE ESTABLISHING A NON BUDGETED FUND
(STATE OF KANSAS BASE GRANT) FOR THE CITY OF
MOUNDRIDGE, KANSAS.**

WHEREAS, the City of Moundridge received a BASE GRANT from the State of Kansas to be used to make infrastructure improvements for future industrial growth; and

WHEREAS, the City of Moundridge, Kansas on the 23rd day of February, 2022 adopted Resolution 2022-06 stating the City's commitment to the purposes set out in the Building a Stronger Economy (BASE) grant; and

WHEREAS, the City of Moundridge, Kansas made a commitment to cover 25% of the infrastructure costs specified in the City's BASE Grant application; and

WHEREAS, the City of Moundridge is specifically planning to make electric and natural gas distribution system improvements related directly to current and future industrial expansions at The Bradbury Company and Tortilla King.

WHEREAS, pursuant to K.S.A. 12-16,111 and Kansas Home Rule, the City of Moundridge, Kansas deems it necessary and prudent to establish a non-Budget Fund, being "BASE Grant Project" number 55, to be used for the following purposes:

- (a) Record the deposit of the BASE Grant Funds; and
- (b) Commit 25% matching City funds to be deposited and recorded as a 25% matching payment of improvement, as provided in the BASE Grant application; and
- (c) Pay for electric and natural gas distribution system improvements as detailed in the City's Base Grant application; and
- (d) Provide a clear record of deposits and payments made to vendors and contractors as part of the BASE Grant Project.


WHEREAS, the City of Moundridge commitment will come from funds expended from the 2022 municipal budget as well as funds specifically allocated in the 2023 budget to meet the infrastructure needs specifically identified in the BASE Grant application submitted to the Kansas Department of Commerce in February 2022.

WHEREAS, money in this fund is not subject to the budget law and as such the fund can be shown on a non-budgeted fund;

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MOUNDRIDGE, KANSAS:

1. The City of Moundridge hereby establishes a non-Budget Fund, being "BASE Grant Project" number 55, to be used for the following purposes:
 - (a) Record the deposit of the BASE Grant Funds; and
 - (b) Commit 25% matching City funds to be deposited and recorded as a 25% matching payment of improvement, as provided in the BASE Grant application; and
 - (c) Pay for electric and natural gas distribution system improvements as detailed in the City's Base Grant application; and
 - (d) Provide a clear record of deposits and payments made to vendors and contractors as part of the BASE Grant Project.
2. Said grant proceeds and City matching deposits in the "BASE Grant Fund" are to be used to help pay electric and natural gas distribution system improvements related directly to current and future industrial expansions at The Bradbury Company and Tortilla King; and other future industrial expansions as may be allowed by the BASE Grant.
3. This Ordinance creating the "Base Grant Fund" may be amended from time to time for such lawful purposes for the use of said fund as permitted by law.
4. This ordinance shall take effect and be in full force from and after its publication in the Moundridge City website, www.moundridge.com, which website is designated the official newspaper of said City.
