

## ORDINANCE NO. 1019

AN ORDINANCE OF THE CITY OF MOUNDRIDGE, KANSAS AMENDING CHAPTER VII. FIRE, ARTICLE 2. FIRE PREVENTION; OF THE CODE FOR SAID CITY AS ADOPTED BY ORDINANCE NO. 888; BY ADDING AND ADOPTING NEW SECTION 7-214. NATIONAL FIRE PROTECTION ASSOCIATION STANDARD NUMBER 13 (INSTALLATION OF SPRINKLER SYSTEMS); PROVIDING FOR THE ADOPTION AND INCORPORATION BY REFERENCE OF THE "NATIONAL FIRE PROTECTION ASSOCIATION STANDARD NUMBER 13" (INSTALLATION OF SPRINKLER SYSTEMS), 2016 EDITION; AND PROVIDING FOR PENALTIES FOR THE VIOLATIONS THEREOF UNDER NEW SECTION 7-214a.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MOUNDRIDGE, KANSAS:

### SECTION I. AMENDMENT.

That CHAPTER VII. FIRE, ARTICLE 2. FIRE PROTECTION, of the Code of the City of Moundridge, Kansas as adopted by Ordinance No. 888 is hereby amended by adding and adopting new Section 7-214, "National Fire Protection Association Standard Number 13" (Installation of Sprinkler Systems) and new Section 7-214a, Violations and Penalties, to read as follows:

#### ARTICLE 2. FIRE

##### New Section 7-214. Sprinkler Systems Incorporated

There is hereby incorporated by reference for the purpose of providing regulations for the installation of sprinkler systems in the City of Moundridge, Kansas, the "National Fire Protection Association Standard Number 13" (Installation of Sprinkler Systems), 2016 Edition, including any and all appendices thereto, prepared and published in book form by the N.F.P.A. Any errata officially published shall become a part of the National Fire Protection Association Standard Number 13 when placed on file by the administrative authority. If any conflict or discrepancy exists between this ordinance and the referenced National Fire Protection Association Standard Number 13, the provisions of this ordinance shall rule. No fewer than three copies of the National Fire Protection Association Standard Number 13 shall be marked or stamped "Official Copy as Incorporated by Reference by the Code of the City of

Moundridge, Kansas” and to which shall be attached a copy of this ordinance and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. All administrative departments of the City charged with the enforcement of the ordinance shall be supplied, at the cost of the City, such number of official copies of such International Plumbing Code as may be expedient.


New Section 7-201a. Violations and Penalties.

A violation of any of the provisions of this Ordinance is hereby declared to be an offense and any party, upon conviction hereof, shall be fined in any sum not less than \$10.00 nor more than \$100.00 or be imprisoned not to exceed 30 days or be both so fined and imprisoned for each offense. Each day during which any violation of any provision of this article is committed, continued or permitted shall constitute a separate offense.

SECTION II. EFFECTIVE DATE.

This ordinance shall take effect and be in full force from and after its publication in the Moundridge City website, [www.moundridge.com](http://www.moundridge.com).
