ORDINANCE NO. 1024

AN ORDINANCE AMENDING ORDINANCE 841, CONCERNING CONNECTION FEES FOR WATER, ELECTRIC, RESIDENTIAL GAS AND SEWER; AND REPEALING ANY PORTION OF AND ORDINANCE INCONSISTENT HEREWITH.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MOUNDRIDGE, KANSAS:

SECTION I. AMENDMENT. That Section 1. Connection Charges, of Ordinance No. 841 of the City of Moundridge, Kansas is hereby amended and changed to read as follows:

SECTION I. CONNECTION CHARGES.

- a. The connection charge for installing each 1 inch (or smaller) water meter service shall be, and the same is hereby fixed at \$810.00. Any size larger shall be on an actual additional cost basis.
- b. The connection charge for installing each gas meter service requiring 275 cu. ft. per hour or less shall be \$320.00. Any size larger shall be on an actual additional cost basis.
- c. The connection charge of installing each direct connect single phase electric meter service shall be, and the same is hereby fixed at \$700.00. Any other service shall be on an actual additional cost basis.
- d. The connection charge for connecting each sanitary sewer service shall be, and the same is hereby fixed at \$150.00, and said connection charge shall be paid in advance at the time of obtaining a permit as hereinafter provided.

SECTION II. SUBSTITUTE PROVISIONS. The Governing Body of the City of Moundridge, Kansas, is hereby authorized to adopt by Resolution a schedule for any change in Water, Electric, Residential Gas or Sewer connection fees, which any new connection fees would go into effect upon passage of such Resolution.

SECTION III. REPEAL. Any ordinance or parts of ordinances of the City of Moundridge, Kansas inconsistent or in conflict herewith are hereby repealed.

SECTION IV. EFFECTIVE DATE. This ordinance shall take effect and be in full force from and after its publication in the Moundridge City website, www.moundridge.com, which website is designated the official newspaper of said City.
